Freedom of Information (Scotland) Act 2002

Request

Please find below our response to your correspondence dated 10 January, in which you made the following request under the Freedom of Information (Scotland) Act 2002.

Please provide me with any internal or external correspondence, including any attachments, WhatsApp messages, text messages, instant messaging, memos, OneNotes, minutes, agendas, appendixes or other correspondence, relating to a member of staff from Durham Police who provided advice to Chief Constable Jo Farrell of Police Scotland in October 2023.

Please ensure you include this person's name and rank in your response.

Response

Your request for information has been considered and the Scottish Police Authority is able to provide the following.

Firstly, we would refer to a previous FOI response <u>2023/24-068</u> issued to you which provides some of the information requested in your correspondence of 10 January, see Appendix 1.

Other information held is provided at the end of this response. Some information has been redacted, as this is third party personal data, considered to be exempt in terms of the Act.¹

This exemption is absolute and therefore does not require the application of the public interest test. Whilst you may have a legitimate interest in disclosure of this information, it is our view that those interests are overridden by the interests or fundamental rights and freedoms of the data subjects.

The Authority considers information held which forms part of personnel files² to be exempt in terms of the Act, as to disclose this would be a breach of confidence.³

These exemptions are absolute and do not require the application of the public interest test. Whilst you may have a legitimate interest in disclosure of this information, it is our view that those interests are overridden by the rights of employees and office holders to confidential discussions in respect of their employment.

Regarding name and rank, this information is publicly available⁴. To assist, a link is provided to the <u>draft official report of the Criminal Justice</u> <u>Committee on 20 December 2023</u>, see section 7-8.

Right to Review

If you are dissatisfied with the outcome, you can ask us to review our response. If you want us to carry out a review, please let us know within 40 working days. You must specify the reason for your dissatisfaction and submit your request to <u>foi@spa.police.uk</u> or by letter to Scottish Police Authority, 1 Pacific Quay, Glasgow, G51 1DZ.

If you remain dissatisfied after review, you can appeal to the Scottish Information Commissioner within six months. You can apply <u>online</u>, by email to <u>enquiries@itspublicknowledge.info</u> or by letter to Scottish Information Commissioner, Kinburn Castle, Doubledykes Road, St Andrews, Fife, KY16 9DS.
