#### **PURPOSE**

The purpose of this paper is to update members on the progress of the extended roll out of Taser within Police Scotland, with specific reference to the use of Taser on persons under the age of 18.

Members are invited to note the information contained within this report.

#### 1. BACKGROUND

- 1.1 In January 2021, the Police Scotland Strategic Leadership Board approved a new operating model for Taser across Scotland. This included an increase to the number of officers trained in Taser over the next three years from around 500 to around 2000 officers. The new operating model was subject to extensive consultation and was thereafter presented to the Scottish Police Authority Policing Performance Committee on the 1 September 2021.
- 1.2 During the meeting on 1 September, further information was requested by the committee around any potential impact on the use of Taser on children. Subsequently a letter was sent to the Chair of the Committee from ACC Mark Williams, outlining these impacts. The information contained within the letter is also outlined in this report with some additional statistics.

#### 2. UPDATE ON INCREASE - TASER TRAINED OFFICERS

- 2.1 Since 1 September 2021, 112 additional officers have been trained in Taser and deployed in possession of the device across Scotland. It is planned that a further 185 officers will be trained before the end of this financial year (31 March 2022), bringing the total number of deployable officers in trained in Taser across the country to approximately 820. These officers will deploy from 87 response hubs across Scotland
- 2.2 As previously stated, to support the increase in officers, a local and national communications and engagement plan was implemented. This involved Local Policing Commanders engaging with their Local Scrutiny Committees providing further information and detail around the impact of this change in their local communities. Nationally, a number of engagement and information sessions were undertaken which resulted in feedback and further development of the Police Scotland Equality and Human Rights Impact Assessment with regards to the use of Taser.
- 2.3 As a result of these engagement sessions, a number of advocacy groups have agreed to take part in a Taser Advisory Group where they will review, advise and provide valuable oversight and interaction with Police Scotland and our use of Taser.

# 3 UPDATE ON THE USE OF TASER

- 3.1 Between 1 April 2020 and 31 March 2021, officers in possession of Taser were deployed to 853 incidents. This resulted in 347 uses (116 draw 180 pointed and 51 discharges of the device). This included 13 uses (5 draw, 6 pointed and 2 discharges of the device) on persons under the age of 18.
- 3.2 Since 1 April 2021, officers in possession of Taser across Police Scotland have been deployed to 1,370 incidents. This has resulted in 238 uses (95 draw, 100 pointed and 43 discharges of the device). This includes 20 uses (5 draw, 13 pointed, 2 discharges of the device) on persons under the age of 18.
- 3.3 To date, Taser use during this financial year has increased by 7 uses on those under the age of 18 years compared to last financial year. This is predominantly due to an increase in deployable Taser trained officers this financial year compared to last. In comparison to the previous years, in 2018-19 there were 12 uses with no discharges to those under the age of 18 years. In 2019-20 there were 9 uses with no discharges to those under the age of 18 years.
- 3.4 The overall position with regards to those under the age of 18 years, since the introduction of Taser to Police Scotland in 2018, has resulted in the device being used (drawn or pointed) on 54 occasions, including discharging on 4 occasions against those under the age of 18 years. A full breakdown can be found in Appendix A. It should be noted that although the device has been used 54 times on persons under 18, 24 of these uses were draws only where the device was not pointed at the child. In respect of discharges, one 15 year old, one 16 year old and two 17 year olds were involved. These discharges were referred to the Police Investigations and Review Commissioner who reported they were satisfied the use of the device was appropriate and proportionate.
- 3.5 Taser use on under 18's accounts for under 5% of all uses and under 2% of all discharges.

#### 4 POLICE SCOTLAND POLICY

4.1 Police Scotland has no specific policy on the use of Taser involving children under the age of 18 years. Any use of Taser must meet Police Scotland's criteria for the use of force in that it must be

proportionate, legal, accountable, absolutely necessary and ethical. Each use is assessed on the particular circumstances of the incident and threat being faced by the officer or public. It would be impossible during a violent and volatile situation, where life could be at risk, for officers to distinguish between someone who is, for example, 16 or 18 years of age. It is vital that the threat and risk posed is the primary consideration.

- 4.2 The Taser X2 has been subject of rigorous independent medical testing. It is acknowledged that there is an increased risk to children and person's with a smaller stature and these increased risks are thoroughly covered within the training to officers around the use of Taser.
- 4.3 The National Taser Unit has engaged with Police Scotland's Children & Young People Strategy Unit which has resulted in specific engagement sessions with the Children and Young People's Centre for Justice who work for improvement in youth justice. A specific engagement session with the Scottish Commission for People with Learning Disabilities/Scottish Network for Reduction of Restrictive Practices (SNRRP), who work around restraint on children and young people, was also held. These groups have agreed to become part of the Taser Advisory Group.
