PURPOSE

This report provides the Legal Committee with the findings of a recent survey conducted with Board Members and stakeholders, seeking their feedback on the overall effectiveness of the committee.

The report is for Members consideration and seeks to inform overall evaluation of the committee's effectiveness during 2024/25, and subsequent assurance report to the Audit Risk and Assurance Committee in May 2025.

The paper is presented in line with the Authority's Corporate Governance Framework and committee Terms of Reference.

1. Background

- 1.1 The Scottish Police Authority is committed to continuous improvement in the discharge of its responsibilities and its oversight and support for policing in Scotland. The <u>Authority's Corporate</u> <u>Governance Framework</u> is subject to regular review with the most recent review reported to and approved by the Authority in November 2024. In addition, the Authority conducts an annual self-assessment of the effectiveness of Committees.
- 1.2 The Authority enhanced the 2024/25 committee effectiveness process by inviting key stakeholders to offer their assessment and views on the effectiveness of each of the Authority's committees. The stakeholders listed below were invited to complete a survey and offer comments. All stakeholders consulted have contributed to and/or attended a committee in the last year:

- 1.3 To encourage open and frank responses, Members and stakeholders were invited to complete the survey anonymously.
- 1.4 To support accountability and transparency, the Authority is reporting the survey findings and holding all committee effectiveness discussions in public sessions of committee meetings.

2. Further detail in relation to the report

- 2.1 There are no specific requirements or direction on how public bodies should undertake effectiveness reviews. The Authority considers a range of relevant documents including <u>'On Board'</u> guidance, the Scottish Government <u>Audit and Assurance Committee Handbook</u> and the CIPFA Good Governance Standard for Public Services.
- 2.2 The committee effectiveness survey for 2024/25 sought feedback in four key areas:
 - Reporting to committees
 - Committee priorities and progress

- Members' capability and overall operation of the committee
- Delivery against the Terms of Reference
- 2.3 All members of the Legal Committee completed the survey. Three responses were submitted by stakeholders, with one commenting on the Legal Committee.

3. Members survey findings

3.1 The responses to questions in the survey used the scale set out below. The analytical tables show how many Members gave a particular response to each question.

- 3.2 **Reporting to committee -** There is a high level of agreement among Members regarding the overall quality, clarity, and content of committee papers.
- 3.3 One Member noted an improvement in the explanations on the progress of individual cases. The Member also noted that further lessons learned are needed on settlements and require input from divisions on actions being taken and the measurement of the overall impact.

3.4 **Priorities and progress -** There is majority agreement among Members that the work of the Committee has a strong strategic focus, although there is a lack of certainty regarding organisational culture, tracking progress, and impact.

3.5 One Member did note that it is unclear how much action is being taken to address issues much earlier to avoid further claims or settlements.

3.6 **Members and overall operation** – All Members agreed that they are confident, agree positions, provide genuine challenge, seek assurances. The majority of Members agreed that they have the right balance of skills, knowledge and experience.

3.7 **Governance Support and Remit** - Members all agree that the Committee receives appropriate advice on taking certain agenda items in private, and that minutes of meetings are of a high standard. The majority of Members agree that the Committee's remit is fit for purpose.

3.8 One Member noted that the Committee would benefit from more sitting legal expertise to be able to provide effective challenge.

- 3.9 **Terms of Reference** Four out of five Members indicated that the Committee is fully discharging its responsibilities in line with its terms of reference.
- 3.10 Overall, the results for the Legal Committee are positive, with a few areas for improvement identified.
- 3.11 Area where consideration might be given for improvement include:
 - A greater emphasis on equality, human rights, or community impacts in reports to the committee; and
 - A greater focus on organisational culture in the work of the committee.
