### Introduction

Police Scotland delivers a national police service across the length and breadth of Scotland.

The Scottish Police Authority (the Authority / SPA) is the oversight body responsible for providing governance, promoting continuous improvement, and holding the Chief Constable to account. It is also responsible for providing Forensic Services.

The Authority, working with Police Scotland, produces the Annual Report and Accounts each year. We use a range of evidence to report on performance against the strategic police priorities, set out in the <u>Joint Strategy for Policing</u>.





This **Performance Summary** presents a selection of the key performance and financial figures provided in our full <u>Annual Report and</u> <u>Accounts for 2023-24</u>.

As set out in the foreword from our Chair, Martyn Evans, the Authority assesses that the overall performance of policing and Forensic Services in Scotland remains strong. Further insight and analysis can be found in the full report.

### **Overall crime in Scotland in 2023-24**

The number of crimes recorded by the police is one of our key performance measures for policing in Scotland.

Alongside this we also look at the number of these crimes that have been solved by the police, known as the detection rate.


Crimes recorded in 2023-24	475,584	3% increase from last year	0.2% higher than 5-year average
Crimes detected in 2023-24	65%	slightly lower than 67% last year	lower than the 5- year average of 68%


# Types of crime in Scotland in 2023-24




#### Group 7: motor vehicle offences



### **Contacting the police**



In addition to calls, 193,155 Contact Us emails and 116,379 online reports were received.

Over 60% of these contacts resulted in an incident being raised - a total of 1,581,710 incidents for the year.


- 98% required some kind of police response
- 11% required an immediate response
- 38% required a prompt response
- 27% led to a crime being recorded

Incident demand has increased by 6% when compared to last year.

Levels of satisfaction for those who have contacted the police is measured through an independent survey.

This is sent each month by text message to 14,000 people who have contacted the police. In 2023-24 over 30,000 responses were received. 78% said it was easy or very easy to contact the police

67% said the police provided the appropriate response

50% felt they were adequately informed about progress


#### Focus on... fraud

Fraud continues to be an area of focus due to a steady increase in the number of crimes over the last five years, and low detection rates.


Fraud is where deception is used for personal gain. It includes crimes such as bogus callers, credit card fraud, and identity theft. With technology growing, more and more fraud is happening online, and fraudsters are more sophisticated than ever before.

While our figures represent victims that live in Scotland, many online frauds are carried out from outside the UK, making investigation and enforcement more difficult.

Police Scotland work with banks, Trading Standards, and police forces across the world to both prevent and detect fraud.

#### Focus on... hate crime

Hate crime has been an area of focus in the second half of this year, in preparation for the launch of the new Hate Crime and Public Order Act.


Hate crime is defined as any crime that the victim or any other person understands is motivated by malice or ill will towards a social group.

Hate crimes can be verbal or physical and can cover a range of different types of crime including assaults, threatening behaviour, verbal abuse, damage to property, robbery, and online abuse.



The Hate Crime and Public Order Act came into effect from 1<sup>st</sup> April 2024.

Reporting on the new law will fall into next year's performance report.



# **Public confidence in policing**

Public confidence in policing impacts on how safe individuals feel. Communities should feel confident that the police will be there for them when needed, and that they will experience policing in a way that is based on fairness and respect.

Levels of public confidence are therefore another key indicator of performance for policing in Scotland. This is measured through a range of surveys including the <u>Your Police</u> survey, which continues to be the largest of its kind in the UK, and the Authority's own <u>public polling</u>.



#### **Forensic Services**

21.8k cases dealt with in 2023-24 5,441 open cases at year end

#### Key activities this year include:

- Publication of the HMICS review of Toxicology Provision in April 2023, and agreement of a partnership action to address recommendations.
- A renewed Memorandum of Understanding between the Authority, the Chief Constable, and the Crown Office and Procurator Fiscal Service approved in August 2023.
- Post Mortem Toxicology services transferred from the University of Glasgow to Forensic Services, including the opening of a new laboratory in November 2023.
- Creation of a new Forensic Services National Scenes Tasking Unit in April 2024.

Ongoing handling of complaints relating to senior officers, with no decisions made by the Authority challenged in the year

Completion of the Authority's Best Value self-assessment, informing an HMICS review of the SPA Corporate function

Continued delivery and enhancement of Independent Custody Visiting across Scotland, with 1057 visits carried out

Achievement of the Independent Custody Visiting Association Gold Award

Delivery of senior officer and Authority Member recruitment processes Positive turnaround times for Freedom of Information and Subject Access Requests – over 98% on time

### **Financial performance**

#### Break-even

overall spend this year is a break-even position to funding

**£80m** uplift in core revenue funding from the Scottish Government

**£18.3m** additional funding to support the 2023-24 pay deal

**£1.2m** net additional funding provided for funded initiatives and programmes

Throughout the year mitigating actions and savings have been managed and delivered through the Policing Our Communities programme.

This has brought spend back in line with the funded position and therefore delivering a balanced budget position for 2023-24.
