Request

Please find below our response to your correspondence dated 6 February, in which you made the following request under the Freedom of Information (Scotland) Act 2002:

I was wondering whether you may be able to assist me with providing an update on the tender linked below? I am doing some research on specialist aviation services for the police forces across the UK and was trying to find out whether the SPA uses any fixed-wing air support. I'm aware that the SPA uses Airbus H135-T3 rotary <u>aircraft</u>, the contract for which was renewed in <u>2016</u>, but I haven't seen any further references to fixed-wing since that date.

Right to Review

Your request must specify the matter which gives rise to your dissatisfaction and it must be submitted within 40 working days of receiving this response - either by email to <u>foi@spa.police.uk</u> or by post to Corporate Management Team, Scottish Police Authority, 1 Pacific Quay, Glasgow, G51 1DZ.

If you remain dissatisfied following the outcome of that review, you are thereafter entitled to apply to the Office of the Scottish Information Commissioner within six months for a decision.

Should you wish to appeal against the Scottish Information Commissioner's decision, there is an appeal to the Court of Session on a point of law only.
