This has good symmetry with practice in the rest of the UK and brings Scotland more into line with how comparator countries record international crimes. It also means that a crime is being recorded by a police force for all relevant cases (either Police Scotland or another UK Police Force). It is proposed to report on the volume of no crime decisions in the proposed cyber-crime chapter of the National Statistics.
